### Alumni President Discusses Important House Improvements

As I write this article, it's finally starting to feel like spring here in Ithaca. The outdoors is filling with colors as the vegetation decides to make its triumphant return, and we're even getting the occasional warm and sunny day. The 2010–2011 academic calendar is coming to a close with final exams in progress, and 14 of our young men are on the verge of that next big step in their lives; beginning careers in industry, entering military service, or going on to graduate studies. These gentlemen, our brothers, represent the best and brightest that Cornell has to offer. I rest assured that they will go on to make us all proud to call ourselves Phis as they follow their respective paths. I know and expect that these paths will periodically (and often!) lead back to 2 Ridgewood Road.

With the graduation of our seniors, the undergraduate membership will total 27 when we enter fall term, and as is generally the case, recruitment will play a vital role in the 2011–2012 academic year. We will also be bidding farewell to our current graduate educational adviser, Jeff Paley '10, as he completes his Master of Engineering. We now welcome

JR Cho '10, pursuing a Master of Health Administration, as our new graduate educational adviser for the new academic year.

As I anticipated in my *Cayugan* article this past fall, the housing corporation has been fiscally conservative in 2011, on the heels of three major projects this past summer and fall (back yard retaining wall, residential-roof replacement, and window replacements), and with the Cornell-mandated sprinkler system upgrades looming in the not-too-distant future. That being said, we have been keeping up on regular maintenance of the facilities. We were issued a conditional Certificate of Compliance from the Ithaca Building Department earlier this spring and will be rebuilding the exterior stairs along the west side of the building to complete that process. The NYAEFI has been going through a scoping and proposal assessment effort over the past several months, with plans to replace the windows and doors in the library this summer.

My top three maintenance and improvement projects beyond the imminent sprinkler system upgrades (as funds become available) are: significant repairs to the deteriorating

exterior masonry of the house; repair and replace furniture in the Great Hall and dining room; and replacement of the carpeting throughout the residential sections of the house. As I've enumerated in the past, there are many other opportunities for improvement to our facilities, however I feel that these are the most pressing needs under constraint.

I can't highlight enough that it is the generosity of our alumni donating their time, energy, and money that provides the wind to keep the good ship Phi sailing forward and on course. I want to extend a hearty "thank you" to all who have contributed to the housing corporation and/or NYAEFI, and I want to urge us all to keep contributing through this difficult economy. # Thank you, Alumni, for Your Continued Support!

I am excited to report that this semester, many new improvements have been made to the house and property. In my last article, I mentioned a future project that the brotherhood was looking forward to, which involved revamping the library tables and chairs. Earlier this semester, the project was finalized when brothers and employees of Treeforms Amish Furniture installed two new oak tables and 20 new matching chairs. New programs, such as the Phikeia weekly study hours, are benefiting from this vast improvement funded by the New York Alpha Educational Foundation, Inc. (NYAEFI).

Another project funded by the NYAEFI was the wired connection upgrade. CAT-6 cables, replacing the old CAT-5 cables, now run to every residential room, as well as the house and common rooms where internet connection may be needed. Improvements were also made to the computer lab, where high-speed connection cables now run to all the computer stations. The brothers are benefiting from the improvements to navigation speed through the academic database and server.

Along with future work to the library French doors and windows, anticipated projects include replacing the Great Hall


furniture, providing new carpeting for the second floor, future construction work on the backyard, and a house-wide sprinkler system.

The second big improvement this semester, the ethernet cable upgrade, has helped improve the speed of our already solid internet infrastructure. The new house dryers have been working great so far. 








